DOCKING BY-LAWS OF PARTICULAR INTEREST

- 6.1.1 Docks are Club property and are assigned each year to specific members for the accommodation of specific non-commercially operated power boats. member applying for a dock must be the registered owner of the boat in the application. No member may dock any other boat in the space assigned to him/her without the prior consent of the Rear Commodore. Docks are assigned from May 1st to October 1st each year, or as determined by the Board of Directors. A
- 6.5.3 All applicants for docking space must present, with their application, and yearly thereafter, evidence of having Public Liability and Property Damage Insurance on their boats, in the amount of \$2,000,000.00 valid for the full year including winter storage
- 6.5.6 As per the Club lease with the Town of Oakville, no commercial use may be made of any docking space, nor of any boat in the dock. Members who breach our lease agreement are subject to expulsion from the Club.
- 6.4.4 In any case, the Rear Commodore and the Board of Directors have the final decision in the allotment of docks. Any docking grievance must be made in writing to the Board of Directors.

AGREEMENT

- 1 I agree to heed the direction of the Rear Commodore in his wisdom. As set out in Section 6-2 of our By-Laws.
- 2 I understand that I will use the assigned space at my own risk and that I will not hold the Club responsible for the care and protection of my boat or its attachments. Nor will I hold the Club liable for damage or loss of any kind to said boat and attachments.
- 3 I understand that the Club will not be held responsible for injuries to myself, family and/or guests howsoever caused on or around the docks or surrounding property,

WINTER STORAGE APPLICATION
