Excerpts from the By-Laws

- 2.1.3 Every new member must submit to a probationary period of one year from the date of acceptance ... throughout the probationary period the member's conduct and participation in the Club will be reviewed by the Board of Directors.
- 2.2.1 Every candidate for membership must be sponsored by either an associate or active member to whom the applicant is personally known. The sponsor must be in good standing and will be responsible for introductions of the new applicants for the first year.
- 2.2.2 All applicants for membership will use the form or forms provided by the Board of Directors that must be filled out completely and forwarded to the Secretary along with the payment for that particular membership category
- 2.5.1 'All charges, fees and or assessments shall be due and payable within thirty (30) days after the date on which the invoice is submitted...'
- 5.1.1 'The Club is operated solely for pleasure, recreation or other non profitable purposes...'
- 6.5.6 'No commercial use may be made of any docking space, nor of any boat while in the dock.'
